Financial Coaching

The NeighborWorks Montana housing counseling network now supports the focused work of highly-trained financial coaches who can assist clients in reaching their financial goals — whether those goals be housing focused or other. Financial coaches focus on three metrics and have access to tools and tangible supports that guide clients to meet their financial goals:

- Increase in savings
- Increase in Credit score
- Decrease in debt

Foreclosure Mitigation Support

NeighborWorks Montana and its network of housing counselors are noticing an increase in requests for foreclosure mitigation and default counseling supports. NeighborWorks Montana offers funding that support this work statewide. There are five foreclosure-certified counselors who work statewide through in person or remote counseling.

Foreclosure counselors can:

- Help with communication between borrower and servicer/lender
- Guide borrowers through options
- Negotiate work out plans
- Support clients with next steps in housing and financial stability
