HOMEBUYER EDUCATION & COUNSELING Why are they important?

At NeighborWorks Montana, we have found that education and counseling are the cornerstone of a strong foundation that enables homebuyers to be the best homeowners they can be. It equips them with the tools they need to enjoy their home for years to come, in turn strengthening the community around them. Having gone through this process also open doors to programs that may be able to help their home purchase be more affordable.

Please encourage clients to seek homebuyer education as early in their process as possible so they may reap the most benefit and have adequate time for processing. Upon taking the class and receiving counseling, they will have a clearer understanding of:

- their credit and how it affects their home loan
- budgeting
- why inspections are so important
- what they can expect at closing
- and so much more

How does the process work?

- 1. Have the client visit nwmt.org/homeownership or call us at (406) 761-5861 to find a NWMT partner in their area who can provide education and counseling
- 2. The client takes a NWMT in-person HBE class or speaks with the counselor about NWMT online class options
- 3. The client receives their completion certificate upon completion of the HBE class (typically 8 hours) and counseling (typically 45-minutes in person or over the phone)

From there, their lender can talk to them about programs and loan products available through NeighborWorks Montana, Montana Housing, and others that may help make their home purchase more affordable for them.
