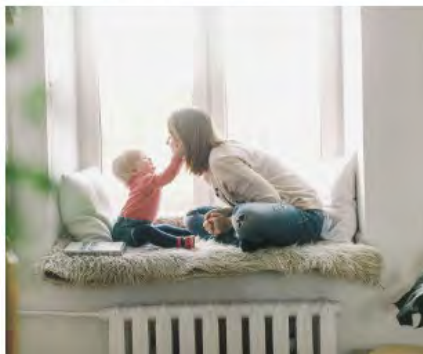

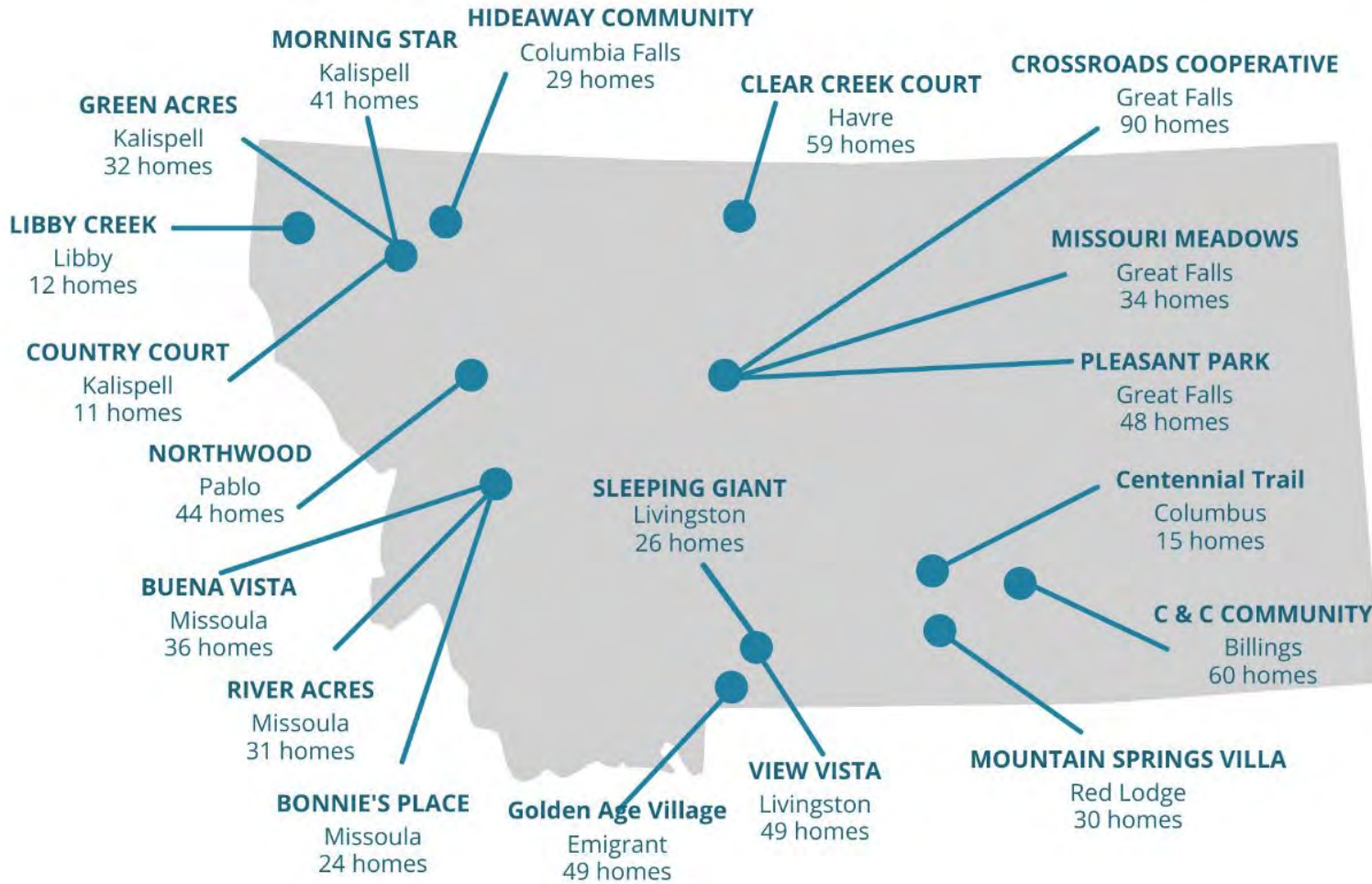

Board Roles

Governance

Adopt and oversee sound, ethical, and legal policies and procedures. Manage the Executive Director.

Fiduciary

Provide financial oversight and ensure the organization has the resources it needs to advance its mission and manages resources effectively.

Strategic

Ensure effective organizational planning. Prioritize organizational activities to create positive impact on people and communities served.



Board Committees

Governance: Board leadership and committee chairs. Duties include personnel, board recruitment, organizational policy, marketing and outreach, and external policy advocacy.

Finance: Financial oversight, financial policies, and annual budgeting.

Loans & Operations: Product and policy development and oversight for homeownership and consumer lending.

Real Estate Development & Acquisition: Product and policy development and loan review for multi-family development lending.

Housing Preservation & Development: Oversee work of the resident-owned communities, housing cooperatives, community land trusts, and other preservation and development efforts.

Partner Relations: Maintain strong and productive relationships with various NWMT network partners. Support program and product development with focus on education and counseling.
